People chose to live here often due to its rural aspect, whilst still being in proximity to larger conurbations. Gradually, over the years, there has been significant new builds and the infrastructure has not changed to accommodate this. Local roads are congested with more and more families often owning several cars. schools are over subscribed, causing more traffic congestion, as children are taken to schools further afield. Local GP's have over full lists, leading to long waits for appointments and GP "burn out". The M60 is a nightmare.</p> <p>Developing more train/ bus services, building more schools, GP surgeries, dentists and sports facilities is not the answer. The answer is by reducing new builds in this already saturated area, and building, if all these new houses are needed, where there is capacity. This could bring improved facilities, where they are currently poor, and improved infrastructure where required, rather than spoiling the established community of Bamford and Norden.</p>
