Horizon 2020 and Cities – Funding Opportunities

The final work programmes of Horizon 2020 (2018-2020) were published on 27 October 2017. Around €30bn in EU Research and Innovation funds has been allocated for the final three years of the programme. Sustainable urban development is also a strong component of Horizon 2020, with emphasis on social innovation and fostering citizen engagement for sustainable and healthy cities. This briefing paper highlights the main funding calls aimed at urban challenges and public authorities.

The briefing also includes the latest guidance to UK applicants in relation to Brexit, and a diagram showing how these funding calls can support the Greater Manchester Strategy.

Introduction

With a budget of €77bn, Horizon 2020 is the biggest EU research and innovation funding programme in the whole EU history. The programme is built around three pillars: 1) Excellent in Science; 2) Industrial Leadership; 3) Societal Challenges.

The main opportunities for cities and public authorities are within the seven Societal Challenges:

1. **Health, demographic change and wellbeing**
2. **Food security, sustainable agriculture and forestry, marine, maritime and inland water research, and the bioeconomy**
3. **Secure, clean and efficient energy**
4. **Smart, green and integrated transport**
5. **Climate action, environment, resource efficiency and raw materials**
6. **Inclusive, innovative and reflective societies**
7. **Secure & innovative societies**

Societal Challenge 1: Health, demographic change & wellbeing



SC1-DTH-05-2019: Large scale implementation of digital innovation for health and care in an ageing society

Scope: Public Procurement for Innovation (PPI) call to purchase and deploy ICT based solutions for active and healthy ageing through a common supply and demand side dialogue, which can deliver sustainable, new or improved health and care services promoting patient feedback in which public procurement approaches for innovative solutions lead to improved outcomes.

SC1-DTH-10-2019-2020: Digital health and care services

Scope: Support to procure the development, testing and implementation of digital services and communication concepts that can facilitate the transition to integrated care models across health and social services and country-specific cross-institutional set-ups, including decentralised procurement environments and collaboration across institutions.

Scope: The scope of this topic is to foster the large-scale pilots for deployment of trusted and personalised digital solutions dealing with Integrated Care, with a view to supporting and extending healthy and independent living for older individuals who are facing permanently or temporarily reduced functionality and capabilities.

Pilot projects should engage partners in regions or cities having adopted or that are in advanced planning for introducing personal medicine approaches.

Scope: Proposals should demonstrate solutions that ensure faster and more cost-effective deep renovations that result in energy performance equivalent to Nearly Zero Energy Buildings.

Scope: Support to address environmental, socio-cultural and spatial impacts of planning in large metropolitan regions, whilst enhancing connectivity; governance and institutional issues should be included.

LC-MG-1-3-2018: Harnessing and understanding the impacts of changes in urban mobility on policy making by city-led innovation for sustainable urban mobility

Scope: City-led proposals to examine the impacts of new mobility solutions, addressing the changing mobility patterns and set up of mobility services, including possible negative effects, and covering all relevant transport modes (including active modes) and vehicle types.

Proposals should demonstrate these services in real life conditions to test the performance, safety and viability of these systems and services and to prove that they are attractive for and accepted by users.

Societal Challenge 5 - Climate action, environment, resource efficiency and raw materials



CE-SC5-03-2018: Demonstrating systemic urban development for circular and regenerative cities	
Scope: Proposals should demonstrate how cities can transition into circular cities by implementing circular innovation and stimulating regenerative practices in both urban and peri-urban areas. Urban makers, fab labs and start-ups should be actively involved to boost creativity and entrepreneurship. Consortiums must comprise at least 4 cities.

SC5-14-2019: Visionary and integrated solutions to improve well-being and health in cities

Scope: Proposals should deliver visionary and integrated solutions (e.g. therapy gardens, urban living rooms, creative streets, city farms) at the intersection of social, cultural, digital and nature-based innovation to increase citizens' health and well-being in cities.

SC5-20-2018: Transforming historic cities and cultural landscapes into hubs of entrepreneurship and social and cultural integration

Scope: Proposals should demonstrate how historic cities and cultural landscapes can be re-activated and re-vitalised through innovative entrepreneurship (e.g. cultural and creative industries, digital technologies, small scale advanced manufacturing), city-makers movements and the integration of new population groups, while respecting the historic heritage environments.

TRANSFORMATION-03-2018-2019: Innovative solutions for inclusive and sustainable urban environments	
Scope: Support to identify the main drivers of inequalities in different urban and peri-urban contexts. Proposals should identify best practices and initiatives, including digital solutions and alternative participatory growth models, with potential for upscaling that can promote upward social mobility, social inclusion and cohesion, resilience and sustainable development.

Funding per project: Up to €1.5m for CSA and up to €3m for Innovation Actions	Type of Action: Coordination and Support Action and Innovation Action

Scope: Proposals should capture successful innovative practices that are emerging in Europe particularly from those urban areas that effectively absorb, develop and create new knowledge and ideas, and turn this knowledge into social and economic development.

DT-TRANSFORMATIONS-02-2018-2019-2020: Transformative impact of disruptive technologies in public services

Scope: Proposals should pilot disruptive technology and should engage multidisciplinary partners, stakeholders and users to examine how emerging technologies can impact the public sector (including the impact on public servants and the relation between public services and citizens) and explore in a wide-ranging fashion the issues surrounding the use of these technologies in the public sector.

UK Participation on Horizon 2020

Following HM Treasury’s statement on 13th August 2016, the UK Government has made the following commitment:

‘UK businesses and universities should continue to bid for competitive EU funds while we remain a member of the EU and we will work with the Commission to ensure payment when funds are awarded. The Government will underwrite the payment of such awards, even when specific projects continue beyond the UK’s departure from the EU.’

'The Government's underwrite commitment guarantees awards where the application is submitted before exit and is subsequently approved after exit. This includes proposals which are informed of their success but, at the point of exit, have not signed a grant agreement, and proposals which have been submitted before exit and that are only informed of their success following exit. We will work with the Commission to ensure payment when funds are awarded'.

'The Government's underwrite commitment covers awards for proposals submitted through a two-stage application process, provided that the proposal for the first stage of the application is submitted before the UK leaves the EU and that the application is subsequently approved'.
