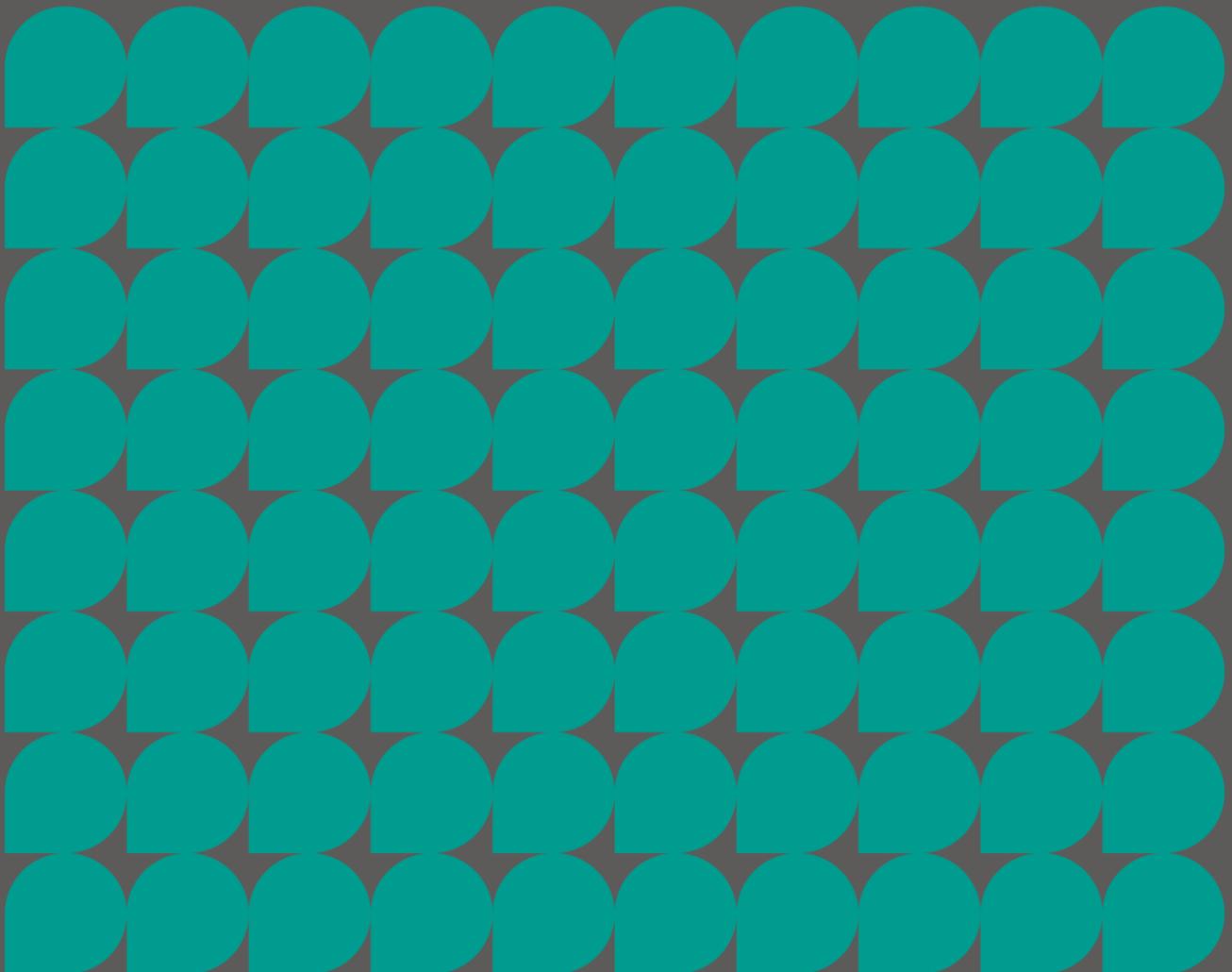

Publication Stage: Places for Everyone (PfE) Joint Development Plan Document, August 2021- Bolton, Bury, Manchester, Oldham, Rochdale, Salford, Tameside, Trafford, Wigan.

Introduction

This Statement meets Regulation 22 (1)(c) (i) and (ii) of The Town and Country Planning (Local Planning) (England) Regulations 2012 and demonstrates that the consultation has been undertaken in accordance with relevant Regulations and Tameside's adopted Statement of Community Involvement (SCI). The Council have consulted bodies, organisations and individuals in accordance with their SCI, using a broad range of methods to advertise the consultation and enable them to submit representations to GMCA; a full range of consultation activities is included in the Appendices below.

Tameside's Statement of Community Involvement (SCI)

The SCI document sets out how the Council will consult and involve the public and statutory consultees in planning matters. The public consultation referred to in this document took place between 2016 and 2021.

The Council adopted their Statement of Community Involvement in 2016¹ prior to the first stage of the Regulation 18 consultation. This was then updated in 2020 to reflect changes to planning legislation, policy and guidance, as well as to reflect the implications of the Covid-19 pandemic on planning-related consultations.

Public consultation under Regulation 19 was undertaken in line with the revised SCI 2021, which included an updated technical narrative around joint planning and the transition from the Greater Manchester Strategic Framework (GMSF) to the Places for Everyone (PfE) Joint Development Plan Document.

Regulation 18 Consultation on GMSF

Public consultation under Regulation 18 of the Town and Country Planning (Local Planning) (England) Regulations 2012 took place in two stages:

Stage 1 took place over a period of thirteen weeks from 14th October to 9th December 2016, which was then extended until 17th January 2017 and focused on the draft GMSF document.

Stage 2 took place over eight weeks from 21st January 2019 to Monday 18th March 2019 and involved the consultation on the Revised Draft GMSF document and proposal plan.

In accordance with pages 9 to 13 of the Council's Statement of Community Involvement (SCI), 31 August 2016, a wide range of methods were used to raise awareness about the consultation, to encourage people to respond, particularly 'harder to reach' groups. This included email/letter notifications to statutory, specific and general consultation bodies held on the Local Plan database. The publicity

methods targeted a full range of stakeholders and included public drop-ins. Traditional forms of publicity using ward councillors, community groups and established networks and partnerships to 'cascade' the information amongst the wider community were also used.

Appendix 1 sets out the specific and general consultees invited to make representations during the consultation, in line with the regulations and the Council's SCI. **Appendix 2** sets out consultation activities and publicity from the 2016 public consultation, **Appendix 3** sets out activities and publicity from the 2019 public consultation and **Appendix 4** shows the evidence of activities carried out during the 2021 consultation.

Further information about who was contacted and how, and who responded will be set out in the **Places for Everyone Statement of Consultation**.

Stage 1 – Consultation on Draft GMSF 2016

GMCA Consultation website

The main method of consultation was through the GMCA consultation portal which provided an online survey and opportunity to provide representations, launched on 14th October 2016 until January 17th 2017. Consultees were invited to respond to this or by writing in an email or letter to the GMCA which allowed the respondents to relate their comments to a specific section or policies within the plan.

The dedicated GMSF webpage set out the core information relating to the GMSF Plan and the evidence base. Consultees could access the GM Spatial Framework, background documents, GM Consultation Map and GM Consultation Statement.

Tameside GMSF dedicated webpage

Alongside this, Tameside Council launched a dedicated webpage which signposted the GM consultation website, provided a short summary of the GMSF; its purpose and content and how bodies, organisations and individuals could submit representations to the GMCA. The details of the public drop-in events were also posted on the Council webpage.

Letter and emails

On launch day, 182 notification letters were sent out to specific and general consultees and all those who had signed up to the Tameside Local Plan database. The letter summarised the GMSF and invited representations through the GMCA website or via email or letter.

A total of 586 emails were sent to community organisations, partnerships and voluntary groups and individuals (including landowners, developers and other interested parties) from the Local Plan database. This email outlined the details of the plan and invited organisations to submit representations to the GMCA website.

Hard Copy Documents

The printed version of the draft GMSF document and proposal plan were made available for the duration of the consultation at the Council's principal office and also in Tameside's libraries, where staff were available to assist in using the library computers to submit representations to the GMCA. The GMCA also made an executive summary document available to all districts; this summarised the plan and illustrated the proposal plans for each district.

Posters

Other publicity included posters, which were placed on public noticeboards in council venues such as civic suites and leisure centres; the posters advertised the consultation period and drop-in events; to raise awareness and encourage participation.

Social Media

Other methods used to reach groups included the dissemination of information via available Council social media and blog posts. Tameside Council Twitter and Facebook accounts contained a number of tweets and posts relating to the events

and to target those who perhaps wouldn't normally participate in council consultations.

Drop-in Events

Two public drop-in events were held in Tameside Central Library, Ashton and Hyde Town Hall in December 2016, both with a dedicated exhibition which summarised the plan and provided an opportunity for the community to understand the proposal plan and process. Planning officers were in attendance to answer any questions raised. These were held on the following dates:

- Thursday 6th December 2016 –Tameside Central Library, Ashton-under-Lyne
- Friday 7th December 2016 – Hyde Town Hall, Hyde

These were well attended and provided an opportunity for the community to further understand the plan and the GMSF process. The attendees were actively encouraged to provide representations via a postcard, via a survey on the GMCA online portal or by email or post.

Stage 2 – Consultation on Revised Draft GMSF 2019

The main method of consultation was again through the GMCA consultation portal. The consultation ran from 21st January to Monday 18th March 2019. Consultees were invited to comment on the Revised Draft GMSF and Proposal Plan and respond to an online survey, by writing in an email or letter to the GMCA, which allowed the respondents to relate their comments to a specific section, policy or allocation within the plan.

Publicity – letters and emails

To publicise the consultation, Tameside used a range of methods including an initial notification letter, which was sent to 193 groups, organisations and individuals (including landowners, developers and other interests) on the Council's Local Plan database. The letter, sent out in January 2019, provided an overview of the GMSF,

the consultation process and encouraged consultees to make representations on the plan. It highlighted the proposed public drop-in events to be held across the district.

A general notification email was sent to 797 email contacts of organisations, groups and individuals (including landowners, developers and businesses) on the Council's Local Plan database; this signposted consultees to the GMCA consultation website for access to the plan, evidence documents and invited representations.

A further email was sent from the Executive Member responsible for forward planning matters to all Tameside Councillors, MPs and Chief Officers. This again provided an overview of the GMSF, how to access information and how respond to the consultation.

Hard copy documents

In accordance with the regulations and the Statement of Community involvement; throughout the duration of the consultation, hard copies of the draft plan were made available at all of Tameside's eight libraries and at the Council's Customer Service Centre (which was also the planning authority's principal office). During the consultation the Council's Central Library and Customer Services Centre combined and moved location; this was expressed in the above communications, and documents continued to be made available throughout the duration of the move.

Consultation notices

To further publicise the proposed allocation sites, a series of laminated consultation notices were placed in and around the three strategic site allocations at easily accessible and visible locations, including along public rights of way. The notices highlighted the GMSF plan consultation and detailed a red edge site boundary for each corresponding allocation. It provided information around the dates of the consultation period and a link to the GMSF consultation portal for more information.

Council Webpage

A dedicated GMSF webpage was launched on the Council's website which provided link to the GMCA consultation portal webpage. An overview of the GMSF was provided including a Tameside-specific context, details of where hard copies of the document could be found, the location, date and time of public drop-in events and how people could make representations.

Public Drop-in Events

An opportunity to learn more about the GMSF plan and process was provided at the nine public drop-in events held by the Council across the borough:

A range of consultation material was readily accessible at the events including summaries of the GMSF and large display boards giving further detail in relation to the three allocation sites proposed within Tameside. Planning Officers were also available to help answer questions on the plan and process. Approximately 200 people attended the events in total, more details are set out in **Appendix 3**.

In addition, a presentation about the consultation was given to the Tameside Youth Council during the consultation period and offers were made to the Ashton Sixth Form College and Clarendon Sixth Form College to provide the same to students who may have been interested.

Newspaper adverts and articles

Publicity in the form of a quarter page advert was placed in the Manchester Weekly News and Tameside Reporter newspapers on Thursday 7 February 2019 with key dates for the public drop-in sessions available. The advert provided the website address for the consultation webpage where readers could access further information and invited representations. In addition, the Stalybridge Correspondent also ran a further 21 articles on the Green Belt issues and GMSF at this time.

Publicity – posters

Further publicity was provided through posters which were displayed in the eight libraries across the district advertising the consultation and drop-in event locations and times. The posters also included the website address for the GMCA consultation webpage for the GMSF.

Social media

As part of the commitment to reach all sections of the community, the Council made use of a range of social media channels; Facebook, Twitter and Instagram to advertise the consultation and over 150 Tweets and Facebook posts were made to residents, organisations and the local business community during the consultation period.

Chief Executive Briefings

The Council's Chief Executive provides a weekly brief to all Council and Tameside and Glossop Clinical Commissioning Group (CCG) staff in which the GMSF featured alongside information relating to the Greater Manchester Mayor's Question Time which occurred within the borough at that time. The email provided context to the GMSF, detailed how to find out more about the consultation and provide feedback, stated where hard copies of the plan could be found and provided information about the local drop-in events.

Spring Citizen Magazine

The Council's 'Citizen' magazine is freely distributed to over 100,000 homes and businesses in Tameside and the Spring 2019 issue featured a full page spread on the GMSF, the timescales for the Plan, some broad background information and where more information could be found. The article also included a quote from the Leader of the Council highlighting the importance of the plan.

Council Live Wire Magazine

The Council publishes a monthly staff newsletter for employees of the Council, Greater Manchester Pension Fund and Tameside and Glossop CCG called the 'Live Wire'. The February 2019 edition of the Live Wire featured a half-page spread on the GMSF, providing some background to the consultation and where to find further information, and also listing details of the remaining drop-in events.

Staff Portal – Leader's Blog

On 17 January 2019, the Leader of the Council featured the GMSF as part of her blog postings, highlighting the importance of plan-making, providing background detail in relation to the GMSF, listing the three allocation sites identified for future growth.

Email signature

For a period during the consultation, all Council email signatures included a GMSF signature highlighting the consultation.

Regulation 19 Consultation

Background

The Publication version of the GMSF was due to be released in December 2020 for a period of public consultation, prior to submission to the Secretary of State.

However, following the decision of Stockport Council not to approve the Publication Plan, it was agreed in principle at a meeting of the AGMA Executive Board on 11 December 2020 to prepare a joint DPD for the remaining nine Greater Manchester Authorities.

As with the GMSF, this Joint DPD titled 'Places for Everyone' principally covers strategic policies including housing and employment land requirements and strategic site allocations, Green Belt boundary amendments and associated infrastructure across the nine districts.

Consultation on Places for Everyone was carried out on a joint basis and in line with the Town and Country Planning (Local Planning) (England) Regulations 2012 and each of the nine districts' SCI.

In line with the pages 7 to 11 of Tameside's SCI, 23rd June 2021, the Council used a wide range of consultation methods and activities over an eight week period from 9 August 2021 to 3 October 2021. Some of the methods highlighted in the SCI, such as face to face drop-in events were not considered possible due to the coronavirus (Covid-19) restrictions. The Council tailored its consultation methods to adhere with Government guidance at the time.

Copies of the various letters, emails and publications advertising the consultation are included in **Appendix 4** of this Statement.

Notification letters and emails

Upon publication of the plan on the GMCA's website, the GMCA sent out a formal notification letter to persons or organisations (which included statutory, specific and general consultation bodies and those wishing to be notified following Regulation 18 consultation).

A further 192 letters were sent out to contacts on the Council's Local Plan database; this provided a brief overview of the Plan and set out how to participate in the consultation. A Statement of Representations was sent out with the letters and set out information on where the documents were available for inspection in the borough and how to access a copy of the plan and evidence documents on the GMCA Consultation Portal.

A notification email was sent to 780 contacts on the Council's Local Plan database with a link to the GMCA webpage where the plan document and supporting documents could be viewed. The Statement of Representation was attached to the email.

A further email was sent from the Executive Member for Housing, Planning and Employment to all Tameside Councillors, MPs and Chief Officers in the week commencing 2nd August 2021. This again provided an overview of the PfE Plan and how to access the information and respond to the consultation.

E-Newsletters and Staff Portal

During the consultation, an E-Newsletter was distributed by Tameside Council to residents (on 12 August 2021) and via the staff portal which is available to Tameside Council staff. Information was shared with CCG staff via the CCG Newsletter, which also reaches 37 GP Practices and digital media was made available to the CCG for further advertisement with patients.

Details of the consultation were included in the August 2021 edition of Tameside's Information Ambassador Network E-Newsletter, which was distributed to 300 groups and shopkeepers. Details of the consultation were also included in the Tameside Business E-Newsletter, which is distributed to 2000 employers from small and medium-sized enterprises. The Local Plan database includes approximately 120 community groups, friends of parks associations and resident associations.

Publicity of the consultation was distributed through the Partnership Engagement Network (PEN), Tameside's Independent Advisory Group, Voluntary, Community and Social Enterprise (VSCE) networks, Partner organisation (including Tameside and Glossop Integrated Care) networks and channels, and the Tameside Youth Council. These include a range of voluntary, charity and other community organisations including 'hard to reach' groups.

274 Community Champions were also informed via email and were offered the opportunity to put a poster in local community centres/ facilities either through collection at the local library or directly.

The Inequalities Reference Group were also notified; this forum is drawn from Tameside elected members, Tameside and Glossop CCG, voluntary, community, faith and social enterprise (VCSFE) sector and Tameside Independent Advisory Group with the aim to reduce inequality in Tameside and Glossop.

With the return to schools in September, information was shared with Tameside's Children's Services and the borough's 100 schools via the Headteacher's E-Newsletter highlighting the PfE consultation and encouraging schools to advertise the PfE consultation with their pupils, staff and families.

Email Signature

An email signature was displayed at the bottom of all Tameside Council emails publicising the consultation from 17th September 2021; providing details of the GMCA consultation web page.

Hard copy documents

In accordance with the regulations and in compliance with the SCI, hard copies of the PfE Plan were made available at all of Tameside's eight libraries for inspection. An exhibition was available at Ashton Library within Tameside One, the Council and planning authority's principal office, which included the Proposals Map. Library staff were available to assist those wishing to use the Council's computers to access the GMCA consultation portal (which contained copies of Topic Papers, HRA, evidence base, consultation summary from Regulation 18, statements of common ground with other local authorities and the Integrated Assessment).

Consultation Notices

For the duration of the consultation period to advertise the proposed allocation sites and Green Belt additions, a series of laminated consultation notices were placed in locations in and around Tameside's strategic allocations and the proposed Green Belt additions. These were placed in accessible locations, including where public rights of way crossed or ran close to the sites. The notices provided an overview of the allocation and detailed a red edge site boundary and site address, the consultation period and mechanisms of where and how to find further information regarding the public consultation.

Council Webpage

The consultation was publicised on the Council's website on a dedicated PfE webpage, which also provided a link to the GMCA consultation portal for the duration of the consultation period. An overview of the Joint Plan was provided including a Tameside relevant context, details of where hard copies of the document could be found, along with an explanation of how people could access the other supporting documents and submit representations using the online form, or by email or by post directly to the GMCA.

Social Media

The consultation was further publicised from 5th August 2021 through the use of a range of social media channels, via Twitter, Facebook and Instagram. The Council's pre-consultation posts reached 27.6k followers on Twitter, 14k on Facebook and 2.5k on Instagram.

Regular social media messages continued throughout the consultation period alerting the followers to the consultation. This included a post advertising the live unstaffed exhibition located at Tameside's Well-being Corner, Ashton Indoor Market and Ashton Library. The posts were viewed by 4.6k people on Twitter and 317 people on Facebook during this time.

Dedicated Public Drop-in Exhibition

A dedicated six board exhibition was installed in Tameside's Wellbeing Corner within the Ashton-under-Lyne Indoor Market for the duration of the consultation. The exhibition offered an overview of the PfE Plan, specific details of the allocation sites for Tameside district and details of how to access the document and make representations through the GMCA Consultation Portal. The indoor market is open six days a week (closed on Sundays) to the general public.

A smaller three board exhibition was installed in Ashton Library and was available to view on request. Both were publicised in Tameside Reporter on 14th September 2021 and through the Council's Twitter and Facebook posts.

Posters

Posters were installed in all of the district's libraries to advertise the consultation – some were installed by the Council's Community Champion network and some in venues; they were provided to all leisure centres across Tameside. The posters provided information on how to submit representations regarding the plan through the GMCA website, email and via post.

Newspaper Advert and Articles

A Public Notice inviting representations on PfE 2021 was placed in Public and Legal Notices section of the locally based weekly paper; Tameside Reporter on August 5th 2021.

The Tameside Reporter also ran a column article on the public exhibition on 14th September 2021 and a more general article on 29th September 2021. The Tameside Reporter has 22.9k followers on Facebook and 9.4k on Twitter and therefore provided a good level of publicity to a wide audience across the borough.

Chief Executive Briefing

Tameside's Chief Executive provides a weekly brief to all Council and Tameside and Glossop CCG Staff. Updates on The Places for Everyone Joint Plan consultation were included in the 16th July brief. An additional internal communications blog was posted on 12th August 2021 on the Council and CCG intranet outlining the details of the consultation and how to provide feedback and where hard copies of the plan could be found within the borough.

Executive Leader's Blog

The Executive Leader's Blog in August 2021 also informed the district of the PfE consultation and opportunity for the community to take part and have their say in the consultation.

Council Live Wire Magazine

The PfE consultation also featured in the Council's monthly newsletter 'Live Wire' on 11th August 2021. This monthly staff newsletter reaches employees of the Council, Greater Manchester Pension Fund and Tameside and Glossop CCG.

Specific Tameside phone call enquiries and emails

Any queries made by telephone via a dedicated phone line or email to GMCA regarding specific Tameside allocations or queries were forwarded to the Council's Policy Team to respond to. Residents were encouraged to respond to the consultation via the GMCA consultation portal and guided towards the GMCA website or requested to respond via email or post.

Conclusion

The above summary explains which bodies and persons the local planning authority invited to make representations under Regulation 18 and 19 and how they were invited, having regard to the plan making regulations and approaches set out in the Council's Statement of Community Involvement at the time.

The Council has therefore met the requirements of Regulations 22 (1) (c) (i) and (ii) of the Town and Country Planning (Local Planning) (England) Regulations 2012.







Greater Manchester's Plan for Homes, Jobs, and the Environment (the spatial framework) is about providing the right homes, in the right places, for people across our city region. It's about creating jobs and improving infrastructure to ensure the future prosperity of Greater Manchester.

A Revised Draft plan has now been put together by [Greater Manchester Combined Authority](https://www.greatermanchester-ca.gov.uk/gmsf) (<https://www.greatermanchester-ca.gov.uk/gmsf>), which comprises the Mayor of Greater Manchester and the leaders of Greater Manchester's ten local councils.

The formal public consultation period for the Revised Draft Greater Manchester Spatial Framework (GMSF) commences on Monday 21 January and ends 11:59pm on Monday 18 March 2019. The plan:

- sets out how Greater Manchester should develop up until 2037;
- identifies the amount of new development that will come forward across the 10 districts, in terms of housing, offices, and industry and warehousing, and the main areas in which this will be focused;
- supports the delivery of key infrastructure, such as transport and utilities;
- protects the important environmental assets across the city region;
- allocates sites for employment and housing outside of the existing urban area; and
- defines a new green belt boundary for Greater Manchester

The plan talks about jobs and homes, but it's about so much more than bricks and mortar. It's about reducing inequalities, improving the lives of our residents, and transforming Greater Manchester into the world-leading city-region we know it can be.

The GMSF will be hugely important for the future prosperity of Tameside and proposes:

- To prioritise the regeneration of brownfield land within the urban area for homes and jobs;
- To help meet the housing need of our residents by creating new places following Garden Village principles, providing much needed affordable homes; and
- To identify the physical and social infrastructure that is needed to support new development such as new roads, public transport, and education and health facilities.

The proposed new plan will add 140 hectares of land to the Green Belt and remove 215 hectares of land from the Green Belt. Overall, this means 74 hectares of land or 1.5% of the total Green Belt would be lost to deliver homes and jobs – however this is a 82% reduction in the loss of Tameside's Green Belt compared to what was proposed in the first draft of the GMSF consulted on in 2016.







RESIDENTS RALLY AGAINST PLANS TO BUILD HOMES ON GREENBELT

Residents declared a resounding 'no' to plans to build on greenbelt around their town when they met this week.

Some 60 people gathered at the Colene Hotel on Monday to show their opposition to the second draft of the Greater Manchester Spatial Framework (GMSF).

The 'Save our Greenbelt' group has been campaigning since the first draft of the GMSF in October 2015, but now their outsiders have gone following the announcement of the second draft.

The new plans show two major developments in Hyde, which the group is campaigning against - the first is for the Lodgey Green Oakley Village, which is a plan to build 2,300 new houses on land between Halloway and Gee Cross.

The second is for two sites designated as 'black at Hyde', which include plots of land off Bowdler Road and Apethorne Lane. The plans say these sites could yield 440 new homes close to the existing Bowdler and Tameside/Black-poll border.

But the Save Tameside Greenbelt group are strongly against any development of green spaces.

"They have put forward plans for a number of brownfield sites that could be built on before re-

not land is used. Greenfield land is land that has been previously developed but is no longer in use, such as the former ADG Works site or the rail yard used to house Cheshire Towns.

The main topic of discussion on Monday was how to stop the land that is included in the plans being designated as greenbelt. The group says this would stop any development and force planners to look elsewhere.

Targets

Under the GMSF each of the ten boroughs of Tameside have annual targets to reach on housebuilding to provide more than 200,000 new homes across Greater Manchester over the next 20 years.

Tameside has the lowest target of all 10 council authorities, needing to build an average of 465 homes a year over the next 20 years, providing an extra 8,850 homes.

The group argues that the targets discussed were revised the stated target of 400 homes a year and that the houses built will be following from the greenbelt issues around transport and

raised, with campaigners saying that the ADG, along which the new houses would be built, is already one of the busiest roads in the area and gridlocked at peak times. The gathering last shown pictures of the train service from Worsley station into Manchester at peak times which showed parked carriages and no seats.

Two primary schools in the area, Doreton Primary Academy and Gee Cross-Hay Trinity are already oversubscribed and campaigners say that the planned new developments provide no alternative for extra school places.

The leader of the meeting, Col Evans, said 'progress isn't made without protest' and urged those gathered to object to the new plans.

All of the local councillors were invited to attend the meeting, but only Phil Cheevers, Conservative councillor for Hyde already attended.

"I've been a member of the group since its inception and is strongly opposed to any building on greenbelt land," he said. "Strategy and Hyde Conservatives have been involved with The Save Tameside Greenbelt group from day one. We have attended public meetings, been on

the public watch, attended a march in Manchester and helped at local events and other events.

"We do not feel the infrastructure is in place to accommodate all the extra cars that these developments would bring, and there are simply not the school places for the extra children, not forgetting caravans, motorhoms etc.

"The area is defined as greenbelt, to stop the uncontrolled urban sprawl of large built-up areas, in order to prevent Stockport and Hyde from merging into one another.

"We are not against building houses, just the destruction of the greenbelt, because once it's gone, it's gone."

Following the consultation, all the responses will be analysed and a draft plan will be produced for consultation in summer 2019. The final plan will be submitted for examination in early 2020 and adopted late 2020/early 2021.

Cllr Brenda Warrington,
Tameside Council Executive Leader, said:

“It's important we have a plan so we can shape development in the best interests of the borough and local people – otherwise developers will push to seek planning permission in areas they have secured an interest in. The allocations of land to be developed in Tameside aim to be innovative and do something different – creating new places with the necessary supporting infrastructure, including greenspace and recreation.

The spatial framework adds to what we are doing locally to grow neighbourhoods and support communities, where Tameside people can live, work and thrive. We are prioritising the regeneration of brownfield land within the urban area, but that alone is not enough to meet the need for more housing so we are forced to give up some of our greenbelt. However the revised GMSF also puts some land into the greenbelt, so overall that means an 82% reduction in the loss of Tameside's Green Belt compared to what was proposed in the first draft of the GMSF consulted on in 2016. Only 1.5% of the existing Green Belt in Tameside would be lost under the revised proposals.”

If there has been one constant in local government over the past decade, it is that things change. Whether it's because we need to introduce new legislation or regulations handed down to us from Whitehall, or because we've had further cuts imposed upon us by the government, or simply because there's a better and more efficient way of doing things, we are always finding new ways to deliver vital services and invest in our shared future.

That's why I want to take the opportunity to highlight the fact that there are currently two consultations open that will allow you to have your say not just on the future of Tameside, but the future of Greater Manchester as well.



The first is the consultation on the revised Greater Manchester Spatial Framework, also known as Greater Manchester's Plan for Homes, Jobs and the Environment. As I discussed in my blog last week, the Spatial Framework is a single plan for the development of land for housing and employment that covers all ten local authorities in our city region. This will allow us to deliver the homes and businesses that our residents need at pace and scale, while also ensuring that they are built where we want them to be built. Tameside has identified three major sites for the Framework; Ashton Moss West, Godley Green Garden Village and South of Hyde. Together, these will provide the land for around 2,790 homes and 175,000 square metres of high-quality employment floor space. It is true that some of this land is currently designated as Green Belt; however after listening carefully to our resident's concerns we have reduced the allocation of Green Belt land significantly from the previous draft of the Framework. We have also returned seventeen other sites back into the Green Belt, and introduced additional protections for all of our remaining Green Belt land.



Places for Everyone is a long-term plan of nine Greater Manchester districts (Bolton, Bury, Manchester, Oldham, Rochdale, Salford, Tameside, Trafford and Wigan) for jobs, new homes, and sustainable growth. It has been prepared by the GMCA on behalf of the nine districts.

The plan will determine the kind of development that takes place across the city-region, maximising the use of brownfield land and urban spaces while protecting green belt land from the risk of unplanned development. It will also ensure all new developments are sustainably integrated into Greater Manchester's transport network or supported by new infrastructure.

The plan is the result of a process that began with the publication of the first Greater Manchester Spatial Framework in 2016, and has been informed by the feedback received from residents, businesses and the development industry.

We have now produced what we consider to be our final plan, the one we want to submit to the Secretary of State.

Have Your Say on Places for Everyone

Friday, 20 August 2021

Tameside, along with the rest of Greater Manchester, is committed to securing a better, fairer and greener future for all our residents. As part of that, we are asking you to have your say on the final draft of the GM Places for Everyone plan.



The plan has been in development since 2014, when it was known as the Greater Manchester Spatial Framework (GMSF), and has been informed by the feedback we've received from residents, businesses and developers across many years. Following the withdrawal of Stockport from the GMSF, the remaining nine local authorities of Bolton, Bury, Manchester, Oldham, Rochdale, Salford, Tameside, Trafford and Wigan have chosen to move forward with this new plan, renamed GM Places for Everyone.

Put simply GM Places for Everyone lays out, in detail, what we want to build in Greater Manchester and where we want to build it from now until 2037. It also provides a public record of the house building targets demanded of us by the government, explains why we've chosen to build (or not build) in a given area, and shows what development management criteria we'll use to decide future planning applications. All the projects in GM Places for Everyone have been chosen with a view to maximising the use of brownfield land and protecting as much of our Green Belt as possible. 90% of new homes allocated in the plan will be built in urban areas, and the impact of the city region's Green Belt has been reduced by 60% compared to the previous GMSF in 2016. These new developments will also be integrated into GM's transport network and supported by all necessary infrastructure such as schools, doctor's surgeries and utilities.

In terms of what GM Places for Everyone means for Tameside, we have identified three strategic sites in the borough for growth along with twelve areas that will be added to our existing protected Green Belt land. I understand that some of these decisions have proven controversial for many, but the fact remains that if we do not come up with a realistic and deliverable plan to meet housing targets decided by the government, we run the risk of a development free-for-all as somebody else steps in to build for us. The GM Places for Everyone plan guarantees that any new development in the city region will put the interests of local people first, and protects us from having our future dictated by distant companies that put the interests of their balance sheet first.



The eight-week consultation takes place from 9 August – 3 October. You can look at the full scope of the plan and give your views of its soundness online through the GM Consult website [here](#). 

Places for Everyone will determine the kind of development that takes place across the city-region, maximising the use of brownfield land and urban spaces while protecting green belt land from the risk of unplanned development. It will also ensure all new developments are sustainably integrated into Greater Manchester's transport network or joined by new infrastructure. The plan is the result of a process that began with the publication of the first Greater Manchester Spatial Framework (GMSF) in 2016, and the feedback received from residents, businesses and community organisations. Since then, work has been carried out to reduce the number of proposed sites and the amount of green belt take within sites, and to propose new green belt additions – the result being a 60 per cent reduction in the impact on green belt land compared to the 2016 plan and 90 per cent of new homes being in urban areas. Places for Everyone was developed after Stockport Council decided last year to withdraw from GMSF, with the nine remaining districts agreeing to progress a joint plan.





People in Greater Manchester are being invited to have their say on the new masterplan for building new homes and creating new jobs in the city-region.

Places for Everyone – the successor to the Greater Manchester Spatial Framework (GMSF) – sets out what land will be freed up for development to meet government housing targets up until 2037.

Town halls across the conurbation – except for Stockport, which pulled out of the GMSF last year – have backed the draft document despite opposition from some councillors.

This means that Places for Everyone will go out for an eight-week public consultation, which will run until 3 October.

People will be asked if the plan meets ‘tests of soundness’ before it is sent off to the government for examination.

These include wh by robust evidenc planning policies.

The consultation is the final stage in the preparation of the plan, which proposes to build 165,000 new homes – down from the 227,000 in the 2016 GMSF draft, and with a 60 per cent reduction in green belt development compared to the first version.

Of these homes, 50,000 will be classed as affordable housing, with 30,000 available for social rent.

More than 55 million sq ft of office, industrial and warehousing space is also proposed across the nine boroughs.



CONSULTANCY APPOINTED FOR ST PETERSFIELD

LDA Design have been appointed to plan the next phase of St Petersfield business district in Ashton. The company will be supported by TODD Architects, CBFL, Curline and Parkize Studio.

St Petersfield, which is home to the Ashton Old Baths date hub, Henry Square and some architecturally impressive Victorian housing, represents a significant regeneration opportunity for Ashton.

Working with officers from our investment and development team, the masterplan will look to create a significant new place for people to work, which integrates with the wider town centre and complements the prominent and historic location.

The plan will seek to bring together previous developments and will enlist the help of key stakeholders, existing occupants and members of the surrounding community.

RECYCLING CHANGES WOULD AID VITAL SERVICES

CHANGES are being proposed for waste and recycling services to help protect limited funds for frontline services.

The council has launched a consultation to involve residents in the plans and give them an opportunity to provide feedback.

Pressures caused by the pandemic, increased demand and 18 years of government cuts, mean the council is faced with having to make savings of another £23 million to balance the budget for 2021/22.

The main changes being proposed involve changing to replacement bins and moving black and blue bin recycling collections to every three weeks. Green and brown bins will remain the same.

Three-weekly black and blue bin collections will be trialed in three areas at the same time as the wider consultation. Households involved in the pilot will receive a letter explaining more and providing details of how they can give feedback.

It's estimated a change of £5.63 for replacement or additional recycling bins, would generate £780,000 a year.

Reverting to collections every three weeks for blue and black bins would save around £284 a year.
